The St. Augustine Yacht Club is proud to invite you to participate in the 1983 RACE OF THE CENTURY.

Date: Sunday, May 29, 1983

Place: St. Augustine - Offshore

Entries and Registration: The enclosed race entry form must be completed in full and returned to the SAYC at the above address no later than 1700 hours (5:00 p.m.) on Thursday, May 26, 1983. Each entry must be accompanied by the \$ 7.50 entry fee.

Eligibility: All yachts must have a valid PHRF of N.E. Florida Rating Certificate. Yachts must be single-hulled vessels of thoroughly seaworthy type, strongly built and rigged, properly ballasted with enclosed cabin and not less than 20 feet L.O.A. This is a category 4 race for equipment and accommodations as shown in the USYRU Offshore Equipment lists.

Management: Race will be under the management of the St. Augustine Yacht Club which will have full power to interpret these conditions. It is the responsibility of the owner and master of each yacht to ensure that the vessel is seaworthy in all respects. The decision to participate in, start, and continue in this race rests sole with each yacht's master.

Skipper's Meeting: A MANDATORY skipper's meeting will begin promptly at 0930 hours at the St. Augustine Yacht Club at Camachee Cove. All Skippers are required to attend. Detailed sailing instructions will be presented at this meeting. The course will be set immediately prior to the Skipper's meeting to take optimum advantage of wind conditions.

Racing Rules: The current racing rules of the International Yacht Racing Union as adopted by the U.S. Yacht Racing Union shall govern except as may be modified by the sailing instructions. The 720 rule shall be in effect (Rule 74.5) and the alternative penalties of Appendix 2 of the IYRU rules shall be in effect.

Protests: Protests must be presented in writing to the race committee at the SAYC within 30 minutes of the time at which the protesting yacht reaches the SAYC at Camachee Cove. Notice of intention to protest must also be given immediately after finishing by a HAIL acknowledged by the committee. If necessary, the Protest Committee will meet at the SAYC.

<u>Classes</u>: The fleet will be broken into a number of spinnaker and non-spinnaker classes. Scratch sheets will be available prior to the race.

Docking: Overnight docking arrangement must be made separately with Camachee Cove Yacht Harbor by Thursday, May 26, 1983. The docking fee will be \$ 10.00 for rafting up within the harbor or 50¢ per foot for a private slip. Telephone (Jax#) 358-7082. A slip is enclosed for your convenience.

Barbeque: The post-race barbeque following the Mayport to St. Augustine race will be held from 1830 hours to 2030 hours on Saturday evening. Tickets may only be reserved by pre-payment of \$ 7.50 per person.
