

**2011 GOLD CHALLENGE

NOTICE OF RACE**

The Coastal Cup is an annual offshore sailing race from Amelia Island, FL to St. Simons Island, GA. The race is hosted by the Golden Isles Sailing Club. Proceeds go to the Golden Isles Community Sailing Center to help fund its youth sailing programs.

**1 RULES**

**1.1** The 2011 Coastal Cup race shall be governed by *The Racing Rules of Sailing 2009-2012*, except as modified by this Notice of Race and the Sailing Instructions. The Golden Isles Sailing Club is the Organizing Authority for this race.

**1.2** Rule 52 is changed so that races may be sailed with the assistance of self-steering gear, electric or wind.

**2 ELIGIBILITY AND ENTRY**

**2.1** The race is open to monohull yachts that are self-righting, properly rigged and fully seaworthy.

**2.2** Eligible boats may enter by completing the attached form and sending it, together with the required fee, to the address below.

**4 CLASSES AND HANDICAPS** Classes will be established for PHRF Spinnaker and PHRF Non-spinnaker. PHRF ratings will be assigned to each vessel.
