## Notice of Race

## Father's Day Regatta

Sunday, June 19<sup>th</sup>, 2016

1. **Rules** The St. Augustine Yacht Club is the Organizing Authority for the Father's Day Regatta. Race will be governed by The Racing Rules of Sailing (RRS); the prescriptions of the United States Sailing Association, and the PHRF rules of the FCSA (<http://www.sailjax.com>)
2. **Eligibility and Entry** All sailboats should have a PHRF rating issued by the First Coast Sailing Association <http://www.sailjax.com>
  - 2.1 Anticipated Classes: Spinnaker, Non- Spin, and Cruising. Three entrants establish a Class.
  - 2.2 Everyone should pre-register. Boats may register on [staugustineyachtclub.com](http://staugustineyachtclub.com). Or by printing the attached entry form and mailing to St. Augustine Yacht Club, 442 Ocean Vista Ave., St. Augustine, Florida, 32080.
3. **Fees** Entry Fee is **\$31.95 tax Inc.** per boat for SAYC members and **\$42.60 tax Inc.** for nonmembers must be paid before the race by cash, check or credit card. Entry fee checks should be made out to the St. Augustine Yacht Club. Members may also choose that the fee be charged to their club account.
4. **Schedule** June 19<sup>th</sup>, 2019
  - 10:00 Skipper's Meeting SAYC Clubhouse, Registrations closed after meeting
  - 12:55 Warning signal for the first class to start
  - 17:00 After race awards party begins
  - 18:00 Father's Day Fish Fry (Advance Reservations Required)
5. **The Courses** The course to be sailed will be an ocean triangle.
6. **Scoring** Following our regular Father's Day tradition this race will be scored with a 3 second per mile adjustment for each father and child or stepchild aboard with a maximum of 15 seconds per mile.
  - 6.1 This race is included in the FCSA Ocean Series and yachts competing will be scored separately for the Series using their normal FCSA class PHRF rating.
7. **Disclaimer of Liability** Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. See RRS 4, Decision to Race. Completion and submission of a registration form for these races constitute an acceptance of an agreement to abide by the Racing Rules of Sailing, this Race Notice and the Sailing Instructions. The organizing authority will not accept any liability for material damage or personal injury sustained in conjunction with or prior to, during, or after the regatta.
8. **Prizes** Trophies will be awarded for first, second, and third for all classes.
9. **After Race Award Party** Captains and crew are invited to the SAYC Clubhouse for the after race Awards party starting at 5pm and the Father's Day Fish Fry to follow at 6pm.
