NOTICE OF RACE AND SAILING INSTRUCTIONS SUNDAY, September 4, 2016

Atlantic Ocean, from St Marys River Inlet to St. Johns River Inlet

1.0 RULES

The race will be governed in order of precedence by (1) this Notice of Race and Sailing Instructions; (2) the rules of the First Coast Sailing Association; and (3) The Racing Rules of Sailing 2013-2016 (RRS).

2.0 MANAGEMENT

The race will be managed by the North Florida Cruising Club, which is also the organizing authority.

3.0 ELIGIBILITY

- 3.1 The race is open to all yachts with a current PHRF certificate from First Coast Sailing Association (FCSA www.sailjax.com)
- 3.2 Yachts that do not have a current PHRF rating assigned by the FCSA may obtain a provisional new rating (\$35.00 first-time annual fee) that will be submitted to FCSA for formal review. The NFCC Club Handicapper is Bill Weinbecker (william.weinbecker@gmail.com)
- 3.3 A yacht participating in the Spinnaker or Non-Spinnaker Class shall have sail numbers on the mainsails, spinnakers, and all headsails with an LP exceeding 130% of J. A yacht sailing in the Cruiser Class shall have an identifying sail number on her mainsail.

4.0 REGISTRATION and ENTRY FEE

- 4.1 The standard FCSA race entry form (www.sailjax.com/Standard-Race-Entry-Form.pdf) must be completed in full, and along with the appropriate fee shall be filed with the Race Committee by 23:00 Friday, Sept 2.
- 4.2 Participants are strongly encouraged to register in advance by mailing the completed form with the appropriate fee to: NFCC Race Committee, PO Box 24268 Jacksonville, FL 32241 or at the General Meeting on Aug 20th. Registration documents may also be submitted at the Sisters Creek dock on Friday evening, Sept 2.
- 4.3 The entry fee is \$40.00. Make checks payable to: North Florida Cruising Club.

5.0 CLASSES

The fleet will be divided into three classes: Spinnaker, Non-Spinnaker, and Cruiser. A Spinnaker Cruiser Class or Multihull Class may also be created with at least three registrants. Refer to PHRF Rules of FCSA definitions and rules pertaining to the Cruiser Class.

6.0 SCHEDULE OF EVENTS

Competitors Meeting: None

All Classes Start Race: 09:30 AM, Sunday, Sept 4, 2016.

7.0 NOTICES TO COMPETITORS

- 7.1 This 4-page document is the only printed Notice pertaining to the running of the race.
- 7.2 A Race Notice pertaining to any changes to the start and running of the race will be made by VHF radio transmission on Channel 72 at 08:00 Sunday, Sept 4. This Race Notice will be repeated at 08:30. If unable to receive by VHF radio for this purpose, a yacht shall telephone the Race Committee at (904) 229-6130 to receive the Race Notice. The Race Notice via the VHF radio will be given even if there are no changes in the Sailing Instructions.

8.0 THE START

- 8.1 All yachts are required to set their timepiece in synch with the USNO time (refer to 11.0).
- 8.2 No yacht shall start prior to 09:30:00 as synchronized with USNO time.
- 8.3 Engine propulsion shall be disengaged at four minutes prior to the designated start time.
- 8.4 Starting Penalties Any vessel early over the line will perform an 'end to round' on either side of the starting line and restart the race (RRS 30.1).

8.5 **If the Race Committee Boat is present**

- 8.4.1 RC Boat will synchronize with USNO time on the VHF radio
- 8.4.2 Follow the horns and flags from the Race Committee Boat
- 8.4.3 The RC will used RRS Rule 26, 5-minute start sequence.

8.6 If the Race Committee Boat is NOT present

- 8.5.1 Yachts shall self-start.
- 8.5.2 No yacht shall start prior to 09:30:00 as synchronized with USNO time (refer to 11.0).
- 8.5.3 The start line shall be an imaginary line connecting St. Marys entrance buoys G15 an G13. A yacht shall have started when any part of her hull, crew, or equipment touches this imaginary line while sailing in the proper starting direction from north to south.
- G-15 is located at N 30° 42.592, W 81° 23.189. G-13 is located at N 30° 42.618, W 81° 22.386.

9.0 THE COURSE

- 9.1 After the start, Performance Spinnaker and Non-Spinnaker classes shall proceed about 19.279 NM to St. Johns entrance buoy STJ leaving it to starboard, and then about 2.167 NM to the finish line. STJ is located at N 30° 23.589, W 81° 19.140.
- 9.1 After the start, Cruising classes shall proceed 18.705 NM directly to the finish line.
- 9.2 For the safety of all race participants, the NFCC Race Committee strongly recommends the wearing of a life jacket during the race.

10.0 THE FINISH

- 10.1 The finish line shall be an imaginary line connecting St. Johns entrance buoys R-4 and G-3, with R-4 to starboard and G-3 to port. Each yacht shall record its own finish time when it touches this line with any part of its hull, crew, or equipment while sailing in the proper finishing direction from east to west. (R-4 is located at N 30° 23.894 / W 81°21.605).
- 10.2 As a courtesy the finishing yacht should make an obvious turning maneuver and simultaneously sound a horn to indicate it has finished racing.
- 10.2 Using a timepiece that is synchronized with USNO time (refer to 11.0), a yacht shall record its own finish time (to the second. When possible, note the finishing times of nearby yachts (hence the turning maneuver and courtesy horn).
- 10.3 As soon as practical after finishing, a yacht shall report its finish time to the Race Committee via VHF channel 72. If unable to communicate by radio for this purpose, a yacht may telephone the RC at (904) 229-6130. Leave a message via text message or voicemail with: boat name, finish time and a call back number (text message is preferred- speak CLEARLY). In no case shall a yacht fail to report its time directly to the RC any later than one hour following its finish.

11.0 TIME

- 11.1 All published times used in association with the race will be Eastern Daylight Savings Time (UTC minus 4 hours in 24 hour format). Use the US Naval Observatory Master Clock telephone voice announcer: (202) 762-1401 or (202) 762-1069. Each yacht shall synchronize its timepiece to this standard.
- 11.2 The time limit shall be 10 hours. A boat failing to finish within this time limit will be scored "Did Not Finish" without a hearing. This changes RRS Rule 35 and Rule A4.1.

12.0 PROTESTS

- 12.1 Protests shall be submitted in writing to the Race Committee by either hand delivery or mailing to the address given in SI section 4.2.
- 12.2 Notice of protest shall be required when the yacht has finished or withdrawn from the race and in no event shall be more than one hour following the yacht's finish time.

13.0 TROPHIES

1st, 2nd, and 3rd place flag trophies may be awarded in Spinnaker, Non-Spinnaker, and Cruiser classes regardless of class size at the September 15, 2016 General Club meeting. Additional flag trophies may be awarded for other classes as defined in 5.0.

14.0 POST-RACE

If possible, provisional race results will be announced at the Regatta Party at Fernandina Marina (17:00). The results will be posted on the FCSA website www.sailjax.com. Race results will also be announced at the NFCC General Meeting on Thursday, September 15, 2016 7:30 PM.
