Smyrna Yacht Club has been hosting this race in either its Michelob Cup or Brewers Cup form since 1999.

The race has become a notable feature on the Indian River (Intercoastal Waterway).

It is a downwind "FUN" race between the Smyrna Yacht Club and Mosquito Lagoon, a distance of about 10 miles. The direction – either racing north or south -- is chosen to create a downwind race, which allows many of the boats to fly spinnakers.

In addition we use a staggered start so that as many boats as possible will finish the race together. This can be particularly exciting if the handicappers get it right and the finish is at the Smyrna Yacht Club.



Each entry will receive multiple beer tickets for the on tap beer of their choice, as well as have the opportunity to take a trophy home. The cost of entry is \$25 per boat. The Notice of Race is available on line at
